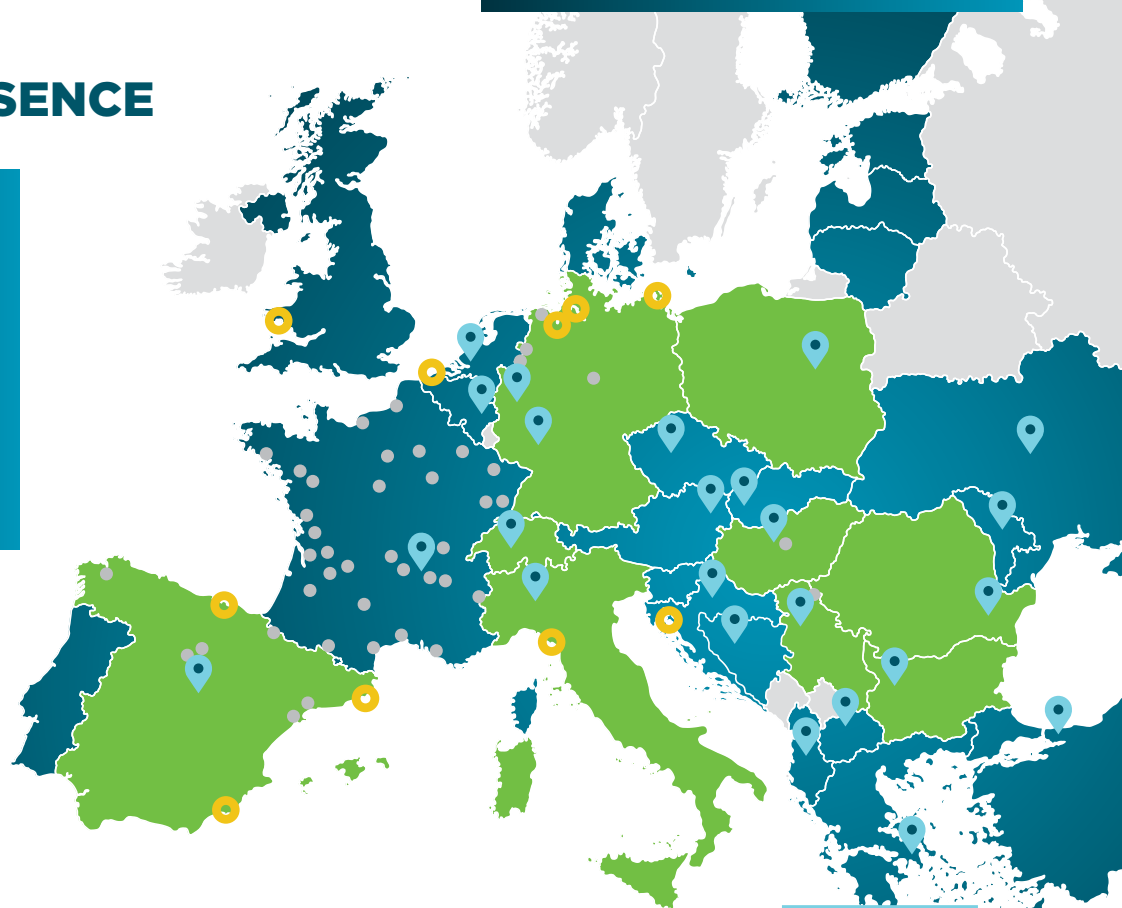

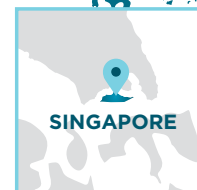

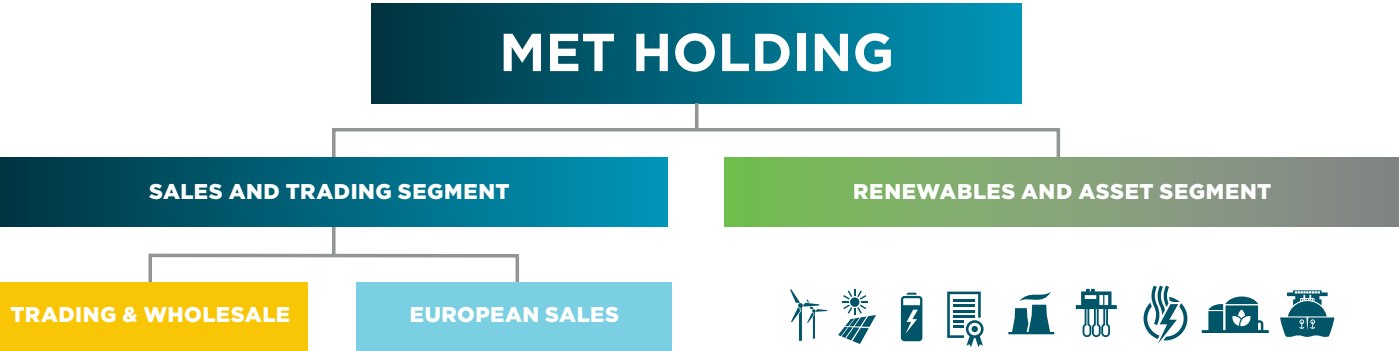

RENEWABLES AND ASSET SEGMENT

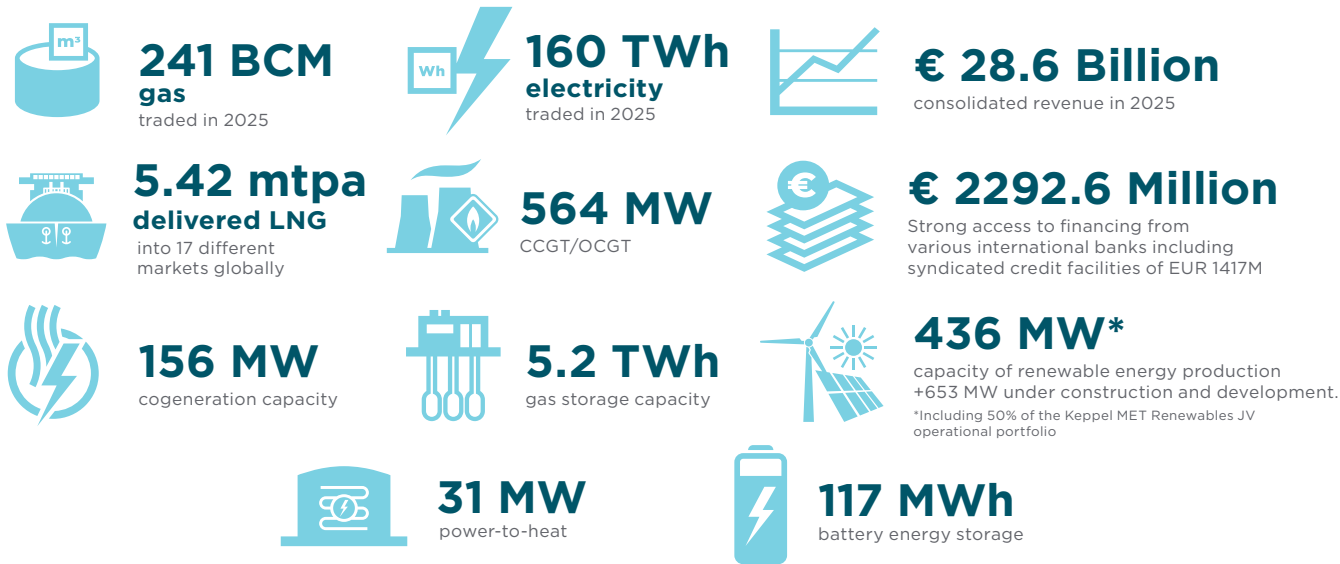
The Renewables and Asset Segment is an integral part of our strategy to drive profitable decarbonization and support the energy transition.
